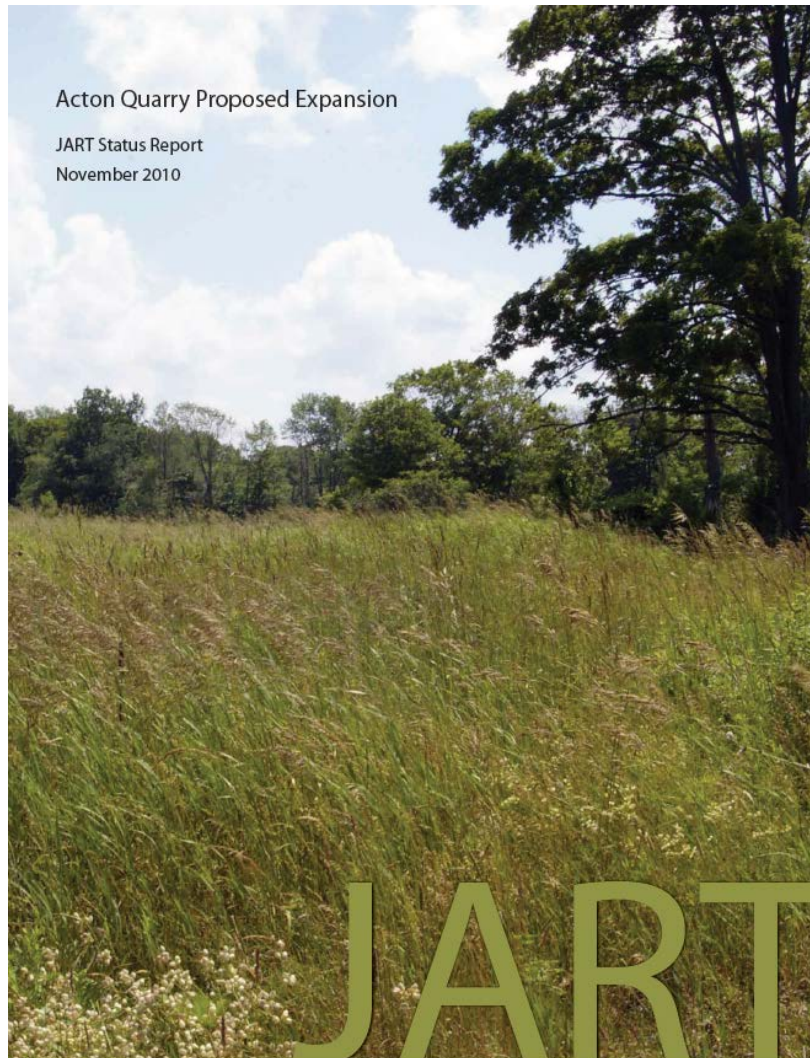
## The Joint Agency Review Team hosted a Public Information Meeting on Nov. 29/10 and issued a Technical Progress Report at the meeting

- JART meeting was held from 6:30 to 9:00 p.m. on Monday November 29, 2010 at the Acton District High School.
  - Open House format from 6:30 to 7:00 p.m. with display boards
  - Meeting Presentation and Q & A from 7:00 to 9:00 p.m.
- Meeting was attended by representatives of JART Agencies, Peer Reviewers, Dufferin Aggregates, and members of the public.
- Approximately 20 members of the public attended this meeting.
- Introduction by Nancy Mott-Allen (JART Chair & Sr. Strategic Advisor for the Niagara Escarpment Commission).
- Steven Rowe (JART Aggregate Advisor) gave a presentation on the status of the JART technical review process.

## JART Interim Technical Report details the status of each individual discipline and the issues that remain to be resolved



- Interim report contains information that we expected to see as it relates to items we have been working through as part of the JART review process.
- There are a few issues that remain but for the most part a great deal of work has been completed to date to get process to where it is now.
- Dufferin Aggregates will continue to work with the JART agencies over the coming months to resolve outstanding issues and satisfy any concerns.
- We expect a final JART Technical Report could be ready by late spring 2011.

# Halton Hills Report presented to Council on December 16/10 on Acton Quarry Expansion and Rehabilitation Plan

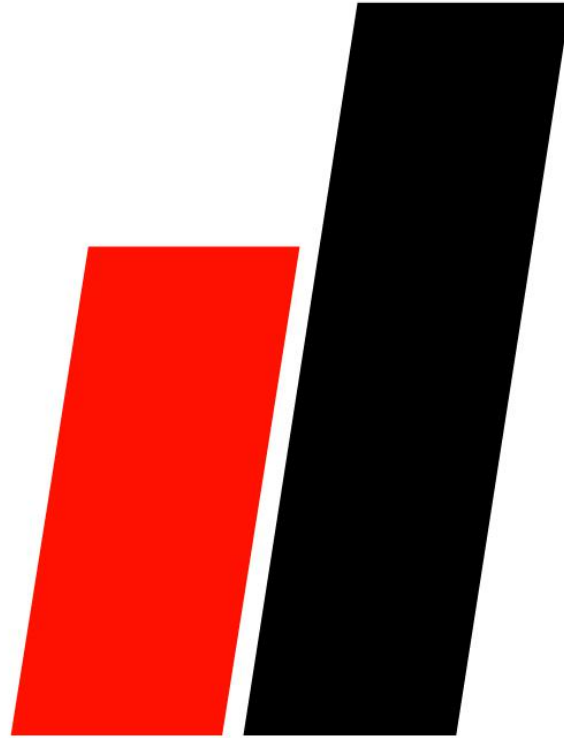
- The Town of Halton Hills CAO (Dennis Perlin) presented a report requesting that Mayor Rick Bonnette and Town Council hold a Council workshop (open to the public to watch). The purpose of the workshop is to allow Dufferin to begin formal engagement of Council in the proposed Acton Quarry extension process, by starting with Council's vision for the after use of the Quarry.
- Planning for the Council workshop is underway. As the meeting will be open to the public and some time will be set aside for public input, CLC members may want to attend. Date will be confirmed and circulated asap.



The proposed expansion must prove satisfactory to Council terms of the science and environmental remediation and on the understanding that Dufferin obtains all necessary approvals and licenses

- Dufferin wishes to demonstrate to Council the public benefits that there can be from the proposed rehabilitation plan.
- Mayor was approached by CAO and endorsed the Dufferin proposal as long as it was held as an open, public session.
- The workshop will be organized by Staff Task Force Chaired by Terry Alyman, Director of Recreation and Parks.
- Workshop is planned to be held in January/February 2011 with formal public notice going out in advance.
- It will be organized in a manner that allows public to be in attendance at the workshop and to ask questions and/or make comments at appropriate times during the workshop.
- We will continue to update CLC with any further news on this matter and encourage members to participate in the workshop.
